DIRECTIONS - across from St. Mary's Fairgrounds turn on Route 244, go 2 miles and turn right on Breton Beach Road, go 1.6 miles and turn left on dirt road, go 0.5 miles and turn right on driveway.

RULES

1. Entries are \$55.00 per division. Late entries accepted as space warrants and will be \$65 per division. I will accept entries handed into me by Wednesday, October 31st, after that you may not get a spot. Make checks out to AMIT. Six ribbons awarded in each division. *We reserve the right to combine or divide divisions as entries warrant.*
2. Times will be emailed to you and posted on the AMIT website by the Friday before the event. If you need an earlier or later time, please note that on your entry. We will try our best to accommodate.
3. USEF approved helmets are required at all times when mounted.
4. Negative Coggins test within one year mailed with entry.
5. **MEDICAL ALERT-** The USEF has instituted a new rule concerning the vaccination for the Equine Influenza Virus and the Equine Herpes Virus (Rhinopneumonitis). Therefore, horses going to USEF as well as many other competitions are required to have proof of vaccination within six months for both of these viruses. AMIT is highly recommending, but not requiring it for this year.
6. *Refreshments will be sold on the grounds.*
7. In case of poor weather or further questions, you can check the website, email us or call (301) 475-5434.
8. Please be sure to arrive early enough to walk your courses. There will be very little time between dressage and stadium.
9. Refunds, Cancellations, and Scratches: Scratches before the closing date will receive a full refund. Scratches after the closing date will receive a refund less a \$15 office fee if we fill your spot. If we cancel the event, we will issue refunds and be very sad. The St. Mary's College Equestrian Club welcomes any donations (**tax-deductible** donation checks should be made payable to St. Mary's College Equestrian Club).

Due to its schooling nature, this starter horse trial is informal. The horses should be clean, clipped, manes pulled, and the tack clean. Braiding is optional. Riders should be NEAT and must wear a USEF approved helmet, riding pants, and boots with heels. We strongly recommend vests for Cross Country. The courses will be basic.

BEGINNER NOVICE: USEA Beginner Novice Test A 2014, Jumps up to 2'6"

ELEMENTARY: USDF Intro Test C 2015, Jumps up to 2'

INTRO: USDF Intro Test B 2015, Jumps up to 18"

STARTER: USDF Intro Test A 2015, Jumps up to 12", may have a helper/leader (Assisted)
